

GFG 34 RULES

HOW TO PLAY:

Choosing a Team: Owners will pick <u>up to</u> 10 (ten) golfers from "<u>Golfer Value</u> <u>Page</u>" whose total value does not exceed 32,000 pts., (except when using PRESS option.*) OBJECT: If your team makes lots of \$ (or points), so will you!

Changing a Team: Each owner will be allowed to make 5 minor Changes and 2 Major Changes of their team over the course of the year. (Refer to "<u>Schedule</u>" page.) Owners who wish to make these Team Changes, pay \$10 for them . This fee entitles a team to make any or all of the Changes at their scheduled times. If you chose not to make any Changes, there will be no fee. Changes must be made by 12:00 midnight of the Wednesday before the next tournament begins Please remember, <u>any golfers that are dropped from your team, will not be eligible to be picked again</u> for the remainder of GFG 34. Owners are wholly responsible for correct Team Totals. If and when making a Change, a Team Total exceeds the PRESS limit of 32,010 points, the least valuable golfer from the list of newly added golfers will be dropped, to comply with limit.

The Major Changes: It's just like starting over. At the scheduled Major Change periods (refer to "<u>Schedule</u>" page),you will be allowed to change any or all of your golfers, still not in excess of 10 golfers and 32,010 pts.*.

The minor Changes: At the scheduled minor Change periods (refer to "<u>Schedule</u>" page), you will be allowed to change <u>up to</u> 3 of your golfers. You may drop <u>no more than</u> 3 golfers, and, you may add <u>no more than</u> 3 golfers, (and still, team total not exceeding 32,010 pts.*)

[***PRESS:** Any owner, when making changes, (minor <u>or</u> Major), may expand his teams value up from the limit of 32,000 pts. (at a fee of \$1 per additional 1 pt. in Golfer Value.) Example: An owner makes changes to his team, but realizes his total shot 3 points above the 32,000 point limit. With the PRESS option, he would be allowed to make this change by making a payment of \$3 extra, for the PRESS. His team would remain at that value until he decides to make changes (at which time the team's purchase value limit returns to 32,000 pts.*) However, don't forget, there is a 10 point (\$10) limit on any PRESS. Owners are asked to pay for these PRESSES promptly.]

Note: The funds collected from the \$10 Change fees and all PRESSES forms the "GFG Pool". These \$\$ are awarded at the end of GFG 34 and are divided using the same % as the Prizes on GFG 34 Summary Page.

GFG 33 RULES (Cont.)

HOW TO WIN:

THE FedEx CUP SERIES: (Part 1) The Top 3 \$ winners win 1st, 2nd and 3rd place prizes at the end of all 7 Periods. The lowest aggregate totals in rank from these 7 periods win 1st, 2nd, and 3rd, place prizes. Also, the Major Tournaments and the Special Major tournament are in the <u>FedEx Cup Series</u> (Part 1). In the Major Tournaments, (4 events), the top 3 \$ earners win prizes. The winner of the Players Championship wins free entry in GFG 35.

THE CHAMPIONSHIP SERIES of THE FedEx CUP: (Part 2) The 3 tournaments of this series will be totaled individually, establishing Aggregate Scores for each tournament. The 1st, 2nd, 3rd, 4th, and 5th place prizes will be defined by the lowest total Aggregate Scores after adding all 3 tournament team rankings.

HOW TO SCORE:

Scoring For FedEx Series Periods: (Part 1) The 1st, 2nd, and 3rd "Period" prizes are awarded to the 3 teams with the highest total of combined \$ earnings at the end of each period. (In case of ties, prizes will be totaled and split into 2 or 3 parts.)

Aggregate Scoring For Finals of The FedEx Series: (Part 1) and The Championship Series of The FedEx Cup: (Part 2): Using The Championship Series of The FedEx Cup (Part 2) as defined in "How To Win" as the example: (The FedEx Series (Part 1) has 7 periods using the same method.)

FINAL PRIZES : (End Of Year Totals)

LOWEST AGGREGATE NUMBER: 1st, 2nd, 3rd, 4th, and 5th place are winners.

MOST TOURNAMENT WINS : 1st, 2nd, 3rd, 4th, and 5th place are winners.

[Payouts for winnings in GFG 34, including Pool \$\$, will be made at the end of the year.]

<u>LIV Rule</u> – Due to the PGA Suspension policy for Golfers that joined the LIV Tour, these golfers were removed from the GFG 32 Golfer Value Page, making them unavailable for pickup. If a Golfer, who is currently positioned on the Value Page, is suspended due to LIV membership, they will not be removed from the Value Page, but their earnings going forward will not be posted in GFG 34. When suspensions occur, notice will be made to owners ASAP, but it is the responsibility of Owners to manage teams. As of 11/22, 17 PGA Golfers who qualified for Top 125 status in 2023 were removed from GFG, and the Golfers who placed 126th through 142nd on the 2022 PGA Earnings List were added to the end slots of the GFG32 Value Page, to make up the difference. (For historical purposes, but still will apply in the case of LIV suspension.)
